An average of 23 men, women and children – people who live, work or travel throughout WA - are flown to safety by the RFDS every day across our vast 2.5 million km2 state. Last year alone, the RFDS retrieved 8682 patients, treated more than 17000 people at community health clinics facilitated or run by the RFDS and responded to more than 50,000 medical consultation and retrieval advice calls.
